NOTICE OF OPEN HOUSE AND PUBLIC HEARING FOR PROPOSED THOROUGHFARE PLAN AMENDMENT

Background

The Harris County Major Thoroughfare and Freeway Plan (MTFP) was adopted in 2024 for the Unincorporated areas of the county. Currently, a Major Thoroughfare amendment has been proposed as part of single-family subdivision in the Crosby area.

Purpose of Notice

The Harris County Commissioners Court will hold a public hearing and recommendation meeting to receive public input regarding proposed amendments to the 2024 Major Thoroughfare and Freeway Plan (MTFP). The Commissioners Court will consider a request submitted by META Planning & Design as part of the Cedar Pointe subdivision, located near Runneburg Road, Bohemian Hall Road, and the Crosby Freeway (US 90) (**Figure 1**). You are receiving this notice because your property is within 500 feet of the proposed amendments.

Proposed Amendment Details

- 1. Euell Road (from Bohemian Hall Road to Crosby Freeway)
 Proposed Change: Reclassify from a Major Thoroughfare to a Minor Collector
- Lindstrom Road (from Runneburg Road to Euell Road)
 Proposed Change: Remove from the Harris County Major Thoroughfare Plan

These changes reflect alignment issues resulting from previous development, which make connecting Euell Road to the Crosby Freeway infeasible.
